## **Information on the treatment of navigation data**

In compliance with the Privacy Code (art. 13 of Legislative Decree no. 196/2003, and subsequent amendments and additions), **Metal Fittings s.r.l.** wishes to provide the following information on the processing of personal data relating to the user or navigator ("interested") which consults this website. The information is provided only for the **Metal Fittings s.r.l.** website and not for other websites that may be consulted by the user through links (for which reference should be made to the respective privacy information/policy).

## **Types of data processed**

Navigation data. During their normal operation, the IT systems and software procedures used to operate this website acquire some personal data whose transmission is implicit in the use of internet communication protocols. This is information that is not collected to be associated with identified interested parties, but which by its very nature could, through processing and association with data held by third parties, allow users to be identified as navigators. This category of data includes the IP addresses or domain names of the computers used by users who connect to the site, the addresses in URI (Uniform Resource Identifier) notation of the requested resources, the time of the request, the method used in submitting the request to the web server, the size of the file obtained in response, the numerical code indicating the status of the response given by the web server (successful, error, etcetera ...) and other parameters relating to the operating system and the user's computer environment. These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning.

## **Cookie**

Session cookies. The use of so-called session and efficient cookies of the site and its applications. I c.d. session cookies used on this site avoid the use of other IT techniques concerning prejudicial to the confidentiality of users' browsing. This website uses some systems that analyze user navigation to create statistics on visits or to improve the offer of content and possibly position targeted advertising on web pages.

## **Providing data other than browsing data**

Apart from what is specified for navigation data, the user is free to provide personal data registered in the registration or request forms. The optional, explicit and voluntary sending of your e-mail address through the registered forms, the subsequent acquisition of the sender's address, necessary to respond to requests, as well as other personal data entered in the form.

## **Persons in charge and methods of data processing**

For the performance of the activities outlined above, personal data may be known by the staff in charge of **Metal Fittings s.r.l.** (employees and collaborators), within the framework of the structures responsible for services and web services, and will also be processed through computerized procedures and electronic communication, protected by suitable security and confidentiality measures, as well as with methods and logics consistent with the purposes pursued and for the retention times strictly necessary for the fulfillment of contractual and legal obligations. The personal data thus acquired will not be disseminated and may be communicated to the competent public subjects and authorities for compliance with regulatory obligations or for ascertaining responsibility in the event of computer crimes against the site as well as communicated to, or allocated to, third parties, operating in Italy and abroad, which **Metal Fittings s.r.l.** uses for the performance of tasks and activities of a technical and organizational nature instrumental to the functioning of the website. Furthermore, the navigation data may be processed by **Metal Fittings s.r.l.** for further purposes of improvement and development of the web services of **Metal Fittings s.r.l.**

## **Rights of the interested parties**

The interested party may, at any time, assert their rights, as provided for in the Privacy Code (art. 7 of Legislative Decree no. 196/2003). In particular, the interested party may request access to the data concerning him held by **Metal Fittings s.r.l.**, know how they are processed, update them, integrate and correct, if inaccurate or incomplete, request their cancellation or blocking if processed in violation of the law, and oppose their treatment for legitimate reasons or, in any case, when they are used for commercial, promotional and advertising purposes.
